I, STEVE OLIVER, Prosecuting Attorney within and for the Eighteenth Judicial District East of the State of Arkansas, of which Garland County is a part, in the name and by the authority

of the State of Arkansas, on oath, accuse the defendant **JEREMY PICKNEY (B/M DOB: 9-23-86)** of the crimes of **Arson; Aggravated Residential Burglary, II Counts; Theft of Property over \$500; Capital Murder, V Counts; Felony Firearm Enhancement; Theft of a Firearm, II Counts; Theft of Property Over \$2,500**, committed as follows, to-wit:

COUNT I

The said defendant on or about **November 12, 2009**, in Garland County, Arkansas, did unlawfully and feloniously, **acting alone or with one (1) or more other persons**, start a fire or caused an explosion with the purpose of destroying or otherwise damaging property whether his own or that of another person, to-wit: Defendant, or one or more other persons, set fire to a residence at **3458-A Old Airport Road, Hot Springs, Arkansas**, belonging to **Edward Gentry, Jr.**, causing damages in excess of **\$15,000.00** but less than **\$100,000.00**, all against the peace and dignity of the State of Arkansas.

COUNT II

The said defendant on or about **November 12, 2009**, in Garland County, Arkansas, did unlawfully and feloniously, **acting alone or with one (1) or more other persons**, enter or remain unlawfully in an occupiable structure of another and was armed with a deadly weapon or represented by word or conduct that he was so armed, to-wit: a residence belonging to **Edward Gentry, Jr.**, at **3458-A Old Airport Road, Hot Springs, Arkansas**, with the purpose of committing therein **Theft of Property**, an offense punishable by imprisonment, against the peace and dignity of the State of

Arkansas.

COUNT III

The said defendant on or about **November 12, 2009**, in Garland County, Arkansas, did unlawfully and feloniously, **acting alone or with one (1) or more other persons, enter or remain unlawfully in an occupiable structure of another and was armed with a deadly weapon or represented by word or conduct that he was so armed, to-wit: a residence belonging to Edward Gentry, Sr., at 3450 Old Airport Road, Hot Springs, Arkansas, with the purpose of committing therein Theft of Property, an offense punishable by imprisonment,** against the peace and dignity of the State of Arkansas.

COUNT IV

The said defendant on or about **November 12, 2009**, in Garland County, Arkansas, did unlawfully, feloniously and **knowingly, acting alone or with one (1) or more other persons, take or exercise unauthorized control over, or make an unauthorized transfer of an interest in, the property of another person, to-wit: The Defendant stole four (4) Milanni rims and tires belonging to Jeremy Gentry, said property being valued in excess of \$500, with the purpose of depriving the owner thereof,** against the peace and dignity of the State of Arkansas.

COUNT V

The said defendant on or about **November 12, 2009**, in Garland County, Arkansas, did unlawfully and feloniously, **acting alone or with one (1) or more persons, committed or attempted to commit**
