On 02/17/2013 at 1218 hours, I responded to 3809 West Maddox Road in reference to a Disturbance Call. I made contact with the complainant, Larry McElroy.

McElroy stated he was in a verbal argument with his wife, Misty Chambers, and called the Sheriff's Office for assistance because he could not handle the arguing anymore. McElroy stated the argument remained verbal and never became physical.

I made contact with Chambers who stated she and McElroy were never in an argument, but that he was acting strangely.

A departmental ACIC check of McElroy showed he had an active warrant out of the Pulaski County Sheriff's Office for failing to appear on an unsafe driving traffic violation.

I handcuffed and placed McElroy under arrest and transported him to the Pulaski County Regional Detention facility for processing without incident.
