INTERVIEW-OF-SUSPECT

This interview was conducted with MR. COONEY in the polygraph suite of the Arkansas State Police Headquarters in Little Rock, Arkansas, commencing at 9:05 a.m. on September 15, 1982, by INVESTIGATOR DAVE DILLINGER. No one else was present during this interview.

During this interview, which was conducted prior to the administration of a polygraph examination, MR. COONEY stated that, on the evening and night of September 10, 1982, he was with LARRY COONEY, his nephew, until approximately 11:30 p.m. when LARRY dropped him off at his girlfriend's house and took his car. He stated that, on that night he and LARRY COONEY went to Carlisle, to the Carlisle Inn, returning sometime after dark. He stated that, when they arrived in Little Rock, they went to the residence of D. GOMILLION at 28th and High, where they stayed for awhile. MR. COONEY stated that he and LARRY then went over to his residence at 2114 Center Street for approximately twenty minutes. He stated that CARMELLETTA GREEN was present in the home at this time, but there were no adults present. He stated that he and LARRY then went back to the GOMILLION residence.

MR. COONEY stated that, the next day, when he received his car back from LARRY COONEY, he noticed what appeared to be blood on the right side, toward the rear. He stated that his jack was misplaced in the trunk and it showed evidence of having been in the mud, and it was bent. MR. COONEY denied any knowledge of how any of this might have occurred, except to say that LARRY COONEY should know what happened, as he had possession of the vehicle that night.

This interview and subsequent polygraph examinations were concluded at 9:33 a.m.

INTERVIEW OF SUSPECT

LARRY LEWIS COONEY

This interview was conducted with MR. COONEY in the polygraph suite of the Arkansas State Police Headquarters in Little Rock, Arkansas, commencing at 9:52 a.m. on September 15, 1982 by INVESTIGATOR DAVE DILLINGER. No one else was present during this interview.

During this interview, which was conducted prior to the administration of a polygraph examination, MR. COONEY stated that on the evening of September 10, 1982 that he and KENNETH COONEY went to the Carlisle Inn in Carlisle, returning to Little Rock sometime after dark. He stated that they went to the GOMILLION residence on 28th and High and then went from there to Sweet Home with a couple of members of the GOMILLION family with them. He stated that, while at Sweet Home, KENNETH COONEY left for approximately 20 minutes to go to the liquor store and then returned. He stated that this was the only time that KENNETH COONEY was out of his sight. MR. COONEY went on to relate that, after leaving Sweet Home, they returned to the GOMILLION residence in Little Rock and, from there, LARRY COONEY took KENNETH COONEY to his girlfriend's house, where he spent the night with LARRY COONEY taking KENNETH COONEY's vehicle and returning it at approximately 7:30 the next day. MR. COONEY stated that he did not go to KENNETH COONEY's residence at 2114 Center Street on the evening of September 10, 1982 and, to the best of his knowledge, neither did KENNETH COONEY. He stated that they did go by the residence before they went to Carlisle earlier that evening. MR. COONEY also denies any knowledge as to the supposed blood inside of KENNETH COONEY's car and denies any knowledge of what may have caused the jack in KENETH COONEY's car to be bent, misplaced, and muddy.

MR. COONEY denied any knowledge or involvement in the disappearance of CARMELLETTA GREEN and stated that, when they were at the residence earlier that evening, CARMELLETTA GREEN was present and nothing appeared to be amiss.
