I am a voter in School District 5. Jody Carreiro encouraged me to contact you.

I am extremely concerned about the selection process for a new school superintendent. I read all of the links published in the Arkansas Blog concerning the candidate from Springfield IL. At best, he is controversial. Why would you want to hire someone with that kind of past into a district where the School Board members are divided? Why do you want to provide a 6-figure salary only to pay even more for a buyout in a year or two?

I am that rare voter interested enough in funding education that I have voted yes to every financial vote since I moved here in 1998. I am an older voter without children. I would be considered a middle class vote.

And I can flatly state that if I had children attending K-12 schools today, I would NOT be a resident of LRSD and buy into this continual conflict - conflict over the years that does not seemingly result in learning improvements. Yes, I know that charter schools have done a fine job of skimming bright students from the district. But I get the feeling that all you want to do is protect administrative jobs and test one grant program after the other.

I know the classroom teachers perform to the best of their abilities under difficult learning environments. When over fifty percent of their efforts go into discipline, learning takes second place.

You have three other candidates to interview. Surely, one of them would qualify to lead the district and if not get another pool. The Springfield candidate is not the only fish in the pond! It appears that Dr. Holmes is providing good leadership in the interim.
